- o PBS 7005 Moorthy moved to reject and request a resubmission. Passed unanimously. Notes: Lecture contact hours need to be quantified on the Form. Syllabus is missing several elements: PS-22, Academic Continuity Plan, Credit Hour Explanation, etc. The objectives have things that are not objectives (formatting issues?). The pre-requisite statement is vague. Please shorten the catalog description (eliminate first three sentences and grading criteria). There was some discussion as to whether this was truly an independent study class. It has lecture hours and attendance requirements, and likely should be treated as a lecture course. The requirements to submit the NIH proposal limits to US citizens and this should be considered (this requirement should be in the syllabus, not the course description).
- o PBS 7103 Moorthy moved to reject and request a resubmission. Passed unanimously. Notes: Cover page hours should be altered. PS 22 requirements should be detailed for exams and quizzes. Please shorten the course description, if able. There are no listed course objectives. It is not clear who is going to pay for these additional costs if these are passed on to the students, it should be made very clear in the syllabus. Will there be a lab fee request? Remove some template material that was copy and pasted.
- o CHEM 3571 Moorthy moved to approve. Passed unanimously. Notes: Please clarify how PS22 applies if a lab is missed.
- o CHEM 4012 Moorthy moved to approve. Passed unanimously. Notes: Please clarify how PS22 applies to homework and quizzes.

o PADM 3000 – Contact hours missing on Form A, need a rounding policy on the grade section, need Academic Continuity Plan.

o MGT 7902 – Hiatt moved to reject and request a resubmission. The course description should describe that the course is designed for independent research in management. Needs to be at least somewhat descriptive of what will be done. There is not a description of what constitutes pass/fail. There should also be a description of how credit hours are assigned (in other words what work warrants three veruss six hours).

o NFS 7009 – LeMaire moved to conditionally approve. Motion passed unanimously. Conditional on: The grading scale should include a rounding policy (perhaps just stick with points?). There needs to be 15 weeks in the course schedule. The expectation policy should omit the "Many professors consider..." sentence and should update to the modern language. PS22, Disability Services, and Academic Continuity Plan are missing. Please use the modern syllabus template for ease of use.
